- Camp Workers must ensure all campers are always supervised.
- Camp Workers must model a Christ-like lifestyle in actions, attitude, and language.
- Camp Workers must submit to the authority of the Florida District Youth Team and communicate any concerns with campers, fellow workers, etc. to the Youth Team.
- Camp Workers must refrain from initiating touch with any person of the opposite gender and must avoid one-on-one interaction/correction with any camper.
- Camp Workers must refrain from allowing, condoning, encouraging, and/or participating in hazing activities toward campers or fellow workers.
- This application must have both the Camp Worker's signature and his/her pastor's signature. The signatures indicate that both parties acknowledge and agree to the requirements of being a Camp Worker and understand that the Camp Worker's failure to comply to the requirements may result in him/her being relieved of his/her role and responsibility.
